## European Travel Select (ETS)

From 1st January 2022, ETS will apply to selected tariffs. It is a £3.00 daily charge which allows you to use your UK inclusive allowance in Europe Zone 1 and 2. It applies when the user is roaming in a European destination\*.

\*The Republic of Ireland and Isle of Man are excluded from ETS, and will remain as inclusive destinations within our tariffs.

The £3.00 daily charge will be applicable when roaming in the below destinations:

EU Zone 1 – Austria, Belgium, Bulgaria, Canary Islands, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, French Territories, Germany, Gibraltar, Greece, Hungary, Iceland, Italy (inc. Vatican City), Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Monaco, Netherlands, Norway, Poland, Portugal (inc. Madeira), Romania, Slovakia, Slovenia, Spain (inc. Balearic Islands), Sweden  
EU Zone 2 – Channel Islands (inc. Guernsey, Jersey), Faroe Islands, San Marino, Switzerland.

## World Travel Select (WTS)

World Travel Select allows users full access to their UK bundles and allowances whilst roaming worldwide for just £6.00 (exc. VAT) per day.
